1. Training sessions will be scheduled in 25-minute slots at different times. In the request form, participants must indicate their preferred time slot.
2. The rental fee is €10 per seat (without coxswain) for any type of boat. Oars are included in the rental.
3. The rental will be confirmed only after the payment transfer has been received. The payment must be made to IBAN **IT38 R088 1715 8000 0400 0008 745 (BIC: CCRTIT2TSMZ)**. The transfer description must state "TRAINING RENTAL" followed by the club's name. The organization will then confirm the assigned time slot based on the order of received requests.

By signing this form, the applicant assumes, without exceptions of any kind, responsibility for any damage caused to the boats and oars rented, providing reimbursement, upon simple request, of the amount paid for the repairs of damaged boats or for the replacement of destroyed boats. Acknowledges and approves that, at the sole discretion of the Filippi Lido srl shipyard, of the Italian Naval League - Taranto section, in relation to the extent of the damage caused to the boats, an advance payment on repairs may be requested in relation to the extent of the damage assessed at the end of the work.
